

IRONbike REGULATIONS

Art.1 Riders

IRONbike is a solo or two people team race. Riders shall declare if they participate as Team or Solo at the time of registration. A change from team to solo or vice-versa can be made no later than one week before the race, after that date no change can be made. IRONbike has to be considered a very demanding race inspired to the Paris-Dakar Rally. All participants must be over 16 years (parents' authorization required for the minors).

Art.2 Image

Riders undertake not to show obscene, political and/or religious advertising or any other type of advertising that could be in conflict with the official race sponsors and/or with the organizers. Race leaders and winners of free entries to other races worldwide shall wear, if requested by the organizers, the official IRONbike Leader Jersey during IRONbike and during the races they are invited to through IRONbike. Riders authorize the organizers and their partners to the use of their images and their name, for promotional purposes concerning the race in accordance with current privacy rules.

Art.3 Requirements

The event is open to all riders of both sexes aged 16 or over (parental consent needed for riders under 18 years of age). The race is open to UCI-licence holders and to non-licence-holders as follows:

- UCI-licence holders: riders holding a valid licence for Competitive Cycling issued by National
 Federations recognised by UCI, must send copy of their licence by mail at least two months before
 the race and present the original at the sign-in.
- No-licence-holders: riders without a valid cycling licence must hold a sport medical certificate
 issued by a sports medicine doctor or a sports medicine centre stating that they have been
 submitted to a complete cardiac diagnostic test (exercise ECG) and that they are physically fit to
 participate to competitive cycling events. The medical Certificate must be sent by e-mail to
 ironbikeofficial@gmail.com or info@ironbike.it with a copy of ID or passport, no later than June
 30^{th.} After receiving the medical certificate, the Federation which the Organizer is member of will
 issue a Cycling Licence internationally valid until Dec. 31st at the cost of 45 €.

Licences for category "Cycling for all", Triathlon or any other sport are not valid, riders who hold these licences must purchase a new Licence as stated above.

It is understood that all participants must meet the requirements of the anti-Covid rules standards, in force at the time of the race (i.e. Green Pass, PCR or antigenic Tests etc.)

Only mountain bikes in good working order will be allowed to start the race.

Bicycle parts can be always replaced; the whole bicycle can be changed only in case of frame breaking after having given communication to the Organizers.

Bicycles may be propelled only through a chainset and by the rider's leg action, without any form of assistance (electrical or otherwise). Racers who intend to use E-BIKES will not enter the overall ranking.

Art.4 Stage Starts Official stage start will be usually preceded by a briefing explaining all stage details. (see Art. 31).

Art.5 Starting order

At the end of each stage a stage ranking and an overall ranking will be posted.



The starting order of the following stage will be the reverse of the overall ranking, unless communicated otherwise.

Art.6 Special stages: each stage comprises one or more Special Stages (SS) that may be consecutive or interspersed with transfer sections. In case of interruption or suspension of a Special Stage for adverse weather conditions or for a decision of the Organizers, usually motivated by safety reasons, those riders who could not complete the SS will be classified with the slowest time of each category. The race will start again in the first place that can be reasonably linked to the race course (bypass road).

When the Special Stage must be definitely stopped by the Race officials because of prior agreement taken with Local Authority Boards (particularly in foreign countries) the aforesaid rule must be accepted by the riders without any complaint whatsoever.

Art.7 Food Stations One or more food stations are provided along the stages, to supplement the food taken by each rider according to his/her personal needs.

Art.8 Checkpoints

On each stage there will be one or more checkpoints. Hidden checkpoints are not excluded. Riders who are not detected when passing one or more checkpoints or who come from the wrong direction will receive the highest penalty foreseen.

Art.9 Safety provisions

Riders must wear a helmet during the entire race, they must also carry an emergency kit, which must include following mandatory items:(supplied or not by the Organizing Committee).

- Whistle,
- Aluminium survival blanket,
- Rain-proof, windbreaker jacket,
- Mobile phone,
- a lighting system by bike lamp or headlamp (when required by the Organizing Committee)

Riders must communicate their mobile phone number to the Organizing Committee the day of the sing-in, the mobile phone must be kept in a shock proof cover and must be carried all along the race course, it must be used to call the IRONbike emergency line (tel. number on the roadbook) to immediately communicate race withdrawal or any accident noticed or to be contacted by the race officials.

Should any rider or team fail to inform the race office of the withdrawal, and should a search and rescue operation be initiated for such rider or team, the cost of the search and rescue will be for the account of that rider or team.

Search and rescue operations will be planned and carried out by the Organizing Committee according to the situation. In case of injury the rider shall be rescued with proper means and taken to the nearest hospital where any obligations by the Organizing Committee cease.

In case of withdrawal the rider shall be sent to the nearest collection point and driven to the base camp only after the recovery of other riders has been completed. The recovery of the bike, if possible, and its transfer to the base camp shall be carried out with any means and with the greatest care, the Organizing Committee cannot be held responsible for any damages occurred. The recovered bike will only be returned to its owner.

Each rider must pay a deposit of 100 €, the day of the sign-in. The deposit will be refunded at the end of the race or whenever the rider decides to abandon the race.

IT WILL NOT BE REFUNDED IF:

the rider does not communicate to the race officials in due time its withdrawal from the race; the rider does not return the transponder consigned at the start.



The officials shall check the compulsory items at any time during the race.

Art.10 Accommodation

Riders are obliged to sleep at the base camp in a tent, in the open air or in makeshift accommodations. Accommodation in hotels or mobile homes or camper vans are in any case excluded and not allowed.

Art. 11 Luggage

The organization grants the transfer of riders' luggage (30 kilos max excluding tent and any prize won during the race) to the base camps during the whole race. Luggage handling will be done using utmost care, the organizers can however not be held responsible for any damages occurred to fragile goods not properly packed and protected as well as for road or air transport of the riders' bikes. Luggage shall be weighed the first day, exceeding luggage must be left in each own car. Riders must pack and load their own tents and luggage on the luggage vehicle at least half an hour before the start of the first racer or when indicated by the Organizers during the stage briefing.

A reduced luggage (20 Kilos max = max 50 litres capacity = mountain rucksack) is required in high altitude camps, or where expressly indicated by the Organizers. This limit can be further reduced in case of extreme conditions.

Riders delivering late their luggage will incur in the same penalties foreseen for delays on the stage target time.

Art. 12 Riders obligations

Competitors and supporters are obliged to respect the environment. No littering or damage to the environment or any waste whatsoever (water bottles, packaging, bike spares, etc) left on the road and in the locations of the stages will be tolerated. Disposing of garbage of any kind will lead to disqualification. Riders are asked to follow the itinerary, to help other competitors, to inform the Organizer Committee using the cell phone in case of accident, to privilege sportsmanship and fairness, and to conform to any Organizing Committee's decision.

Riders must observe at all times during the race all traffic regulations in force.

Art. 13 Times

For each stage the starting time, the target time (theoretical riding time) and the maximum time (cut-off time) will be fixed

Art.14 Penalties

Stage: 10 points for every minute of delay over the target time (theoretical riding time), i.e. the difference between the target time and the arrival recorded time.

Special stage: 1 point for every second of delay over the fastest special stage time.

10000 points will be charged for: skipping over one stage, not finishing a stage, exceeding the maximum time (cut-off time), failure to respect even one checkpoint, failure to wear the helmet, lack of compulsory equipment or equipment out of order, violation of the safety rules, showing up at the start later than half an hour after the starting time, in this case the rider could even not be allowed to start.

If the stage starts with a transfer section, the rider may arrive later than his/her scheduled starting time (but not over half an hour later). If the stage starts with a Special Stage the rider must start at his/her scheduled starting time. For Special Stages along the stage riders can start when they wish, at set intervals.

There is no separation limit between team members. The team time is the time at which the second team member passes the stage/special stage finish line.

In case of withdrawal riders must inform the O.C. IMMEDIATELY. In the event that only one team member withdraws for personal reasons, the other team member can decide to continue the race as solo with a penalty of 500 points. Tandem bikes will be considered as teams.



Art.15 Intermediate Cut Off Points The C.O. may, at any times, designate intermediate cut-off points on each stage which must be reached within specific times due to safety reasons. Any riders which fail, or will in the sole opinion of the C.O. be unable, to reach intermediate cut-off points will be prevented from continuing to ride, swept from the course and transferred to the race finish.

Art. 16 Finishers Riders who do not finish all stages within the Maximum Time and those who exceed 30000 (50000 for women) penalty points, even though they have finished all stages, will not be considered IRONbike Finishers (they will not therefore receive the finisher T-shirt). The penalty points given for having exceeded the Maximum Time take into account only delays over the Target Time.

Art. 17 Prologue

The race will be preceded by a prologue which determines the first ranking and therefore the starting order of the first stage. The prologue must be considered as a stage, a coefficient can be applied and in case of equality in final results, the ranking of the prologue will be considered.

Art.18 Coefficient

The O. C. has the right to modify the race course for any reasons and to insert coefficients - always previously declared and not applicable after - in order to multiply the penalties' ratio.

Art.19 Fairness

The O. C. undertakes to offer the bikers a situation of equality and to consider all of them on the same level, also from a psychological point of view, making all necessary actions in order to level privileges deriving from being familiar with the race's route, from the nearness to the family, or the assistance from unauthorised persons or staff which is not part of the organisation, Biker's personal assistance can assist only by the official assistance points indicated on the Road Book.

Art. 20 Protests

Any protest including evidence of the same must be submitted in writing and signed to the race jury within half an hour of posting of preliminary results for the relevant stage. A fixed deposit (Federal Committee € 50,00) must accompany any protest before the protest will be considered. If the protest is not upheld the deposit shall not be refunded. The name of the claimant shall or not be disclosed. Deposit can be returned only if the protest is upheld.

Art. 21 Risks

It is believed that the competitor knows:

- even if the organization guarantee a high level of security, it is impossible to avoid "sport risks".
- that entering in this competition has risks and it is possible to suffer both minor and sever injuries in this sport.
- to take responsibility of the "sport's risk", it means that every competitor has to take ownership for his/her MTB riding during the competition and whilst exploring the surrounding area.
- that should you cause injury to another competitor or see a competitor injured on the trail it is your responsibility to stop and assist them until competition first aid arrives.
- that there are many competitors and spectators at this event and it's possible that it will be times where the paths are crowded with competitors who are struggling on trails.

Art.22 Registration The entries will close when the entrant list reaches the target number. The O.C. reserves



the right to refuse an entry without having to give reasons for such refusal.

Art. 23 Prize-giving The prize giving ceremony will take place in the afternoon of the last stage. The prizes can be cumulative and they will be exclusively handed to the winners personally. Prizes in categories will only be paid if there are at least 3 racers in the category, otherwise the racers will participate only to the overall ranking.

The free registrations to races or the travel gift vouchers given as prizes cannot be sold or offered to other persons or used on other dates.

Art. 24 Supporters

Riders can benefit from personal assistance at the base camp or during the race by paying an entry fee of 250,00 € for a "Supporter" until June 30th, after that date the O.C. does not guarantee registration and price, especially for supporters driving big vehicles (such as motor homes).

Registered Supporters must drive their own car or vehicle (van, motorhome etc.), they will receive a bracelet and an identification decal for the vehicle that must be always visible. Supporters are entitled to: transfer rider's luggage, give them assistance at the base camp and at the official food stations indicated on the road book. They can sleep at the base camp and use all services and meals reserved to the riders. Access to high altitude camps may not be allowed to big vehicles.

If requested by the O.C. the supporter's vehicle shall display the IRONbike logo as well as those of any sponsor or partner.

No outside assistance by non-registered persons is permitted under any circumstances. Failure to comply to provision will lead to: verbal warning at the first reprimand, 5000 points of penalty at the 2nd and disqualification at the 3rd.

Art. 25 AOB

The O. C. has the right to modify the present regulations at any time giving notice on the web site, to change the race course, the base camp locations as well as the number of stages. Any modification made during the race which becomes integral part of this regulation will be notified during the daily briefing.

Art. 26 Cancellation Policy

cancellation within May 31st
 cancellation within June 15th
 cancellation after June 15th
 No refund after that date

The date in which the cancellation is submitted to the O.C. is considered valid for the refund. Refund shall be paid by wire transfer within 30 days from cancellation receipt.

The refund policy is valid both for the race entry fee and for the support person entry fee.

In case of cancellation of the event by the organizers due to factors beyond their control, force majeure, such as extreme weather events, earthquakes, flooding, no entry fees will be refunded.

Flight, train or any other transportation tickets will not be refunded in any case.

COVID-19 cancellation policy:

Should IRONbike be cancelled due to COVID-19 sanitary emergency, the paid entry fee will be entirely refunded, less 5€ for administrative costs. The decision to cancel the race will be taken following the guidelines and recommendations of the Italian Government and WHO or/and to protect the health of riders and staff.

The full amount paid will be refunded (less 5€ for administrative costs) also in case a rider renounces to participate to the race because of restrictions imposed by his/her country or other reasons linked to COVID-19 (i.e. restrictions to travel, including mandatory quarantine entering Italy or going back home). This case must be objectively demonstrated and documented.



Art. 27 External services

The mechanical assistance and the massage service will be carried out by an Organization's partner company according to common sales terms. Each competitor shall carefully check that any repairs or replacements are workmanlike performed. The Organisation cannot be held responsible for damages due to badly made repairs.

Art. 28 References

For any subjects not considered in this regulation will be considered valid the regulation of the ACSI ciclismo Sport Promotion Board in force. In case of misunderstandings the Italian version prevails.

Art. 29 Withdrawals during the race

Riders who decide to abandon the race or are disqualified having reached the max. penalties must give the bib number to the Race Officials but are allowed to continue the race, follow it by their own car or with the supporter. They can use all services foreseen for the participants, except the time keeping. The emergency rescue cannot be guaranteed out of the race course or after the broom motorbike has passed. The competitor disqualified by the Race Officials for infringements will have to abandon the raid.

Art. 30 Bib Number

Riders are obliged to display the original (unmodified, unfolded and without adding anything) bib number (the starting number is neither to be changed nor to be made smaller) and the other marks supplied by the organization, in particular the national flag. On the helmet the racer can add any other identification whatsoever, notwithstanding the provisions of Art. 2. Failure to comply to his Article will lead to: verbal warning at the first reprimand, 5000 points of penalty at the 2nd and disqualification abandoning the race at the 3rd.

Art. 31 Briefing

The briefing before each stage will be translated in the most common languages, and will supply all necessary information to find the route and other key information such as difficulties etc regarding the stage itself, target times and maximum times will be also communicated at the briefing. Riders must therefore participate to the stage briefing (teams can be represented by only one member).

Art. 32 Ethical Requirement

By signing and sending the registration form the athlete, together with the team representative, self-certifies that s/he is not serving a ban by a federation for a doping violation. Should this be the case registration will be refused. The athlete, together with the team representative, also self-certifies that no inquiry is underway for events related to doping. The athlete, together with the representative of her/his, team also certifies that s/he has never ever taken doping substances included in the list of the World Antidoping Agency (WADA)(http://www.wada-ama.org/Documents/World_Anti-Doping_Program/WADP-Prohibited-list/2013/WADA-Prohibited-List-2013-EN.pdf). Perjury shall be prosecuted.

Art.33 TREATMENT OF PERSONAL DATA:

In relation to the information notice according to Art. 13 of EU Regulation 679/2016, the competitor must declare that he/she has viewed said information notice published on the website www.ironbike.it and that he/she has been informed as to the compulsory nature of providing consent for the related processing for the purposes indicated under Art. 2) of the aforementioned information notice, through selection for acceptance of the relevant box on the online registration form for the processing of personal data, aware that failure to provide consent for processing of data for the aims indicated in Art. 2) of the information notice, will imply the impossibility to proceed with the registration for the activity in question. The data must be complete and legible also for insurance purposes. With consent for the processing of his/her personal data the competitor expressly authorises the ASD TUTTOCICLO for his/her data to be transmitted



and processed also by third parties who offer services connected with IRONBIKE such as those having the purpose of timing the races, drafting and announcing lists of results and those having aims such as photographing or filming the competitor. For that purpose, please also carefully read the privacy information notices of our partners: SDAM srl, CABLE PRESS According to Art. 4 of EU Regulation 679/2016, processing of personal data means "any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction". In relation to the lists of results and classifications, the publication of photos, videos and audios and/or video recordings of any kind, the company will use such data and images of the athlete for internal and external use (various publications, sports films, electronically and on the company website www.ironbike.com). In relation to the images and/or video recordings, the athlete may appear alone or together with other subjects during the initiatives promoted by and for the Company. The organisation must be authorised by the competitor for the aforesaid processing; the competitor must be informed of the possibility of the right to revoke the processing which can be exercised at any time by writing to ASD TUTTOCICLO info@ironbike.it

Normal luggage must weigh 30 kg tent excluded, except where the organizer otherwise provides. A reduced luggage shall be required in high altitude camps: 50 lt capacity (20 kg) rucksack, except where the organizer otherwise provides.

MANDATORY ITEMS to be carried along the race course (they may be checked at any time during the race):

- A Rigid or suspension MTB
- A approved bicycling helmet
- Whistle
- A Silver rescue blanket
- Mobile phone
- A Dry waterproof or water resistant jacket
- Lighting (flashlight or head lamp) (when required by the O.C.)

MANDATORY ITEMS FOR CAMPING (it may be checked):

- Cutlery, tableware and glass
- Sandals or soft shoes (for admittance in indoor areas)

RECOMMENDED ITEMS

for camping:

- > Tent
- Treated proofed sleeping bag and mat (camps can be at altitudes of 3000 metres)
- Small lamp
- **>** For the race:
- > 2-3 bike pants
- 2-3 jersey
- > 2-3 pairs of socks
- > Dry waterproof or water resistant jacket (MANDATORY) GORE-TEX is good for wind and rain
- 2/3 pair of gloves (we suggest something waterproof and full finger)
- glasses (goggles/sunglasses)
- bike shoes
- knit hat that can be worn under a cycling helmet in cold weather



- > protein bars and energetic drinks and drinking water according to personal needs
- > first aid kit
- > Full length pants or tights
- Fleece (stays warm when wet, and dries quickly)
- Consider a waterproof hat to protect you from the sun or rain
- ➤ After the race:
- > t-shirts
- > shorts, long pants or jeans
- > fleece jackets
- hicking footwears
- waterproof jacket
- warm hat, gloves
- **>** For bike maintenance:
- > 4/5 spare tubes
- > 1/2 spare tyres
- > spoke nipple pan
- > chain tool
- > chain lube
- > spare flasks
